GRANITE REIT DECLARES MONTHLY DISTRIBUTION

January 17, 2017, Toronto, Ontario, Canada – Granite Real Estate Investment Trust ("Granite") (TSX: GRT.UN / NYSE: GRP.U) announced today that its board of trustees has declared a distribution on Granite's stapled units of CDN\$0.217 per stapled unit. The distribution will be paid by Granite on February 15, 2017 to stapled unitholders of record at the close of trading on January 31, 2017. The stapled units will begin trading on an ex-dividend basis at the opening of trading on January 27, 2017 on the Toronto Stock Exchange and on the New York Stock Exchange.

As it relates to certain unitholders, Granite confirms that no portion of the above distribution constitutes effectively connected income and that this release serves as a qualified notice pursuant to United States Treasury Regulation Section 1.1446-4.
