GRANITE REIT DECLARES MONTHLY DISTRIBUTION

February 18, 2014, Toronto, Ontario, Canada – Granite Real Estate Investment Trust (“Granite”) (TSX: GRT.UN / NYSE: GRP.U) announced today that its board of trustees has declared a distribution on Granite’s stapled units of CDN\$0.183 per stapled unit. The stapled units will begin trading on an ex-dividend basis at the opening of trading on February 26, 2014 on the Toronto Stock Exchange and the New York Stock Exchange.
