## **GRANITE REIT DECLARES MONTHLY DISTRIBUTION**

**January 17, 2014, Toronto, Ontario, Canada – Granite Real Estate Investment Trust (“Granite”) (TSX: GRT.UN / NYSE: GRP.U)** announced today that its board of trustees has declared a distribution on Granite’s stapled units of CDN\$0.183 per stapled unit. The stapled units will begin trading on an ex-dividend basis at the opening of trading on January 29, 2014 on the Toronto Stock Exchange and on the New York Stock Exchange.
